Letter from our Founder



Dear Friends.

As I reflect on this past year, I am inspired by the strides we have made together to improve abortion access for people across the United States; considering *Roe* was overturned. When I founded Wellspring in 2021, we began with a vision to provide quality reproductive health care to people living in underserved areas, but it has flourished into a movement powered by your unwavering support and commitment.

This past year, we accomplished remarkable feats. Together, we expanded access to care for under resourced populations by serving folks from 19 different states. In 2024, we saw an increase in our patient volume. Our overall patient volume was at 537, with 380 of those appointments for abortion care. Together with our six physicians and wonderful clinical staff, we were able to provide patients with the care they not only needed but deserved. The contributions that you have so generously provided have gone to help people directly with their abortion care.

We won our court case in the Wyoming District Court. The ruling, which was made by Teton County District Judge Melissa Owens, said the laws violated Article 1, Section 38 of the state constitution, which protects one's independent medical decision-making; free from government interference. We were relieved and delighted that the court ruled not only in our favor, but in favor of all Wyomingites. Immediately after the ruling, the state's Attorney General appealed the judge's ruling, which means we will be before the State Supreme Court in 2025. The fight is not over, but we will be right there with everyone until this is resolved. Looking ahead, our work is far from done. Challenges remain, but so does our resolve. With your continued partnership, we will continue our fight to ensure everyone receives access to abortion care with dignity and privacy; and where their personal decisions are respected. Together, we can build a future where access to health care is no longer a privilege but a fundamental right.

Thank you for standing with us and for believing in a world where abortion is accessible to all who need help. Your support transforms lives. I am deeply grateful to have you by our side.

The Difference Your Support Makes

None of our achievements would be possible without the unwavering support of our donors, partners, and community. Your generosity has enabled us to sustain a win for Wyoming, expand access to care, and strengthen our advocacy efforts. Together, we are making a lasting impact. Key Milestones Achieved Together:

- Victory in Wyoming: We received a favorable ruling in our lawsuit with the state of Wyoming at the district court level. This allows abortion to remain legal while the case continues to the state Supreme Court.
- One and a Half Years of Care: Our clinic has now been open for over 18 months, serving patients from across the country who otherwise have nowhere to turn.
- Expanding Access Beyond Wyoming: We've provided care to patients from 19 states, ensuring those in abortion deserts receive the services they need.
- Legislative Impact: We were able to keep all but one anti-abortion bill from passing and encouraged the governor to veto the billwhich he did!

At Wellspring Health Access, we are committed to providing essential reproductive healthcare to those who need it most—no matter where they live. Despite the increasing barriers to abortion care, our clinic continues to be a beacon of hope for individuals in abortion deserts. Here's a look at our impact over 2024:


By the Numbers:

- Patients Served: Over 700 appointments provided to those seeking
- Supporting Families: 58% of our patients are already parents, with 35% raising two or more children.
- Filling a Critical Gap: We are the only clinic to open in a state that attempted to ban abortion post-Roe.


Every statistic represents a person-someone who overcame obstacles to access the care they deserve. We remain steadfast in our mission to expand reproductive healthcare and stand with those in need.






Our Impact on Access




- Nationwide Reach: Patients traveled from 19 states to access services.
- Long Journeys for Care: Patients traveled an average of 250 miles one way to reach our clinic.
- Financial Assistance Provided: More than 80% of patients required funding support for medical care, lodging, meals, or travel.
